The Internal Revenue Service announced that the nation's Tax Season will begin Friday, February 12, 2021, This is the official date the IRS begins accepting filed returns. Do not be fooled. UBU reminds taxpayers that, by law, the IRS cannot issue refunds claiming the Earned Income Tax Credit (EITC) and the Additional Child Tax Credit (ACTC) before February 15, 2020. While the IRS will process all returns when received, it cannot issue related refunds before February 15, 2020. The IRS expects the earliest EITC/ACTC related refunds to be available in taxpayer bank accounts or on debit cards beginning <u>approximately Friday, March</u> 26, 2021.

UBUTPE will begin preparing and inputting returns as of <u>Thursday, January 2, 2021</u> and will submit the returns to the IRS for receipt and processing once their system opens on January 20, 2019. Although the IRS will begin accepting both electronic and paper returns on January 20, 2019, paper returns will be processed in 6-8 weeks, or less, as the IRS system update and COVID-19 delays. The IRS strongly encourage Taxpayers to file their tax returns electronically and choose <u>Direct Deposit</u> for faster tax refunds. The nation's tax deadline this year is April 15, 2021.

For All New Clients' Early Registration (You will be one of the first to be accepted by the IRS):

- (1) Please visit UBU Tax Professionals Elite's website: www.ubutaxpros.com (Go to Contacts), and
- (2) Complete your Name, Address, Telephone number, Email Address, Name of Person who Referred You (If New Client), and type in the Service Request Box: "Name - 2020 Tax Preparation " and any additional information you would like UBUTPE to know about your 2020 Tax situation. <u>Text the</u> <u>contact number to alert us. Advise if you neeed prior years prepared.</u>
- (3) Then go to Tax Forms. You should see a <u>UBU Tax Client Form</u> and <u>Tax Engagement Letter</u> which you will need to download, complete, sign, print and email to <u>ubutaxes@ubutaxpros.com</u>. If Self-Employed, also complete a Non-W2 Income Statement.
- (4) To expedite the process, <u>Email to ubutaxes@ubutaxpros.com or Fax to (803) 693-0303</u>. On Subject Line, place Your Name – 2020 Tax Preparation. We will place you in the System immediately, begin your tax preparation, awaiting any add'l tax documents to finalize the process as follows:
- 1. 2020 Last paycheck stub (Will need your W-2)
- 2. 2020 W-2 Form
- 3. 2020 1099 Form for Self-Employed Individuals
- 4. 2020 1098 Form for Taxpayers who attended school
- 5. 2020 Health Insurance Information Verification or Hardship Exemption Form
- 6. Complete 2020 UBUTPE Form for Non-W2 Wage Earners, sign and efax to 803-693-0303 or e-mail.
- 7. Complete 2020 UBUTPE Short Form Tax Questionnaire and efax it to 803-693-0303 or e-mail.
- 8. A copy of your unexpired driver's license or other ID (If New Tax Client)
- 9. A copy of your Social Security Card for Taxpayer and Dependents
- 10. For EITC Taxpayers, Immunization and School Records to verify Residency Requirement 12 months
- 11. 2020 Bank Statements, Credit Card or Bank Card Statements the last 12 months
- 12. Bank information, including <u>Routing Number and Account Number</u> for Account you wish your refund to edeposited in.
- 13. 2020 Invoices or Record of Income for Sole Proprietors requiring a Schedule C
- 14. Any and all receipts or other documentation for expenses relating to your 2020 taxes
- 15. If you plan to itemize deductions, fax or e-mail all documentation relating to 2020. Email to: <u>ubutaxes@ubutaxpros.com. All Documents must be legible.</u>

(To Email Docs: Place your Name and Year in the subject line of e-mails) - Example: John Doe - 2020 Tax Documents; for subsequent emails, John Doe - Describe the document you are sending.

Your secured, confidential personal information and Tax Documents will be inputted immediately to get you strted today. You will be placed in VIP Status. Then call and schedule an <u>office or telephone conference</u> for your Tax Preparation Needs. If you have a difficult or special situation, please also call to schedule appt. Don't Delay! Beginning in Tax Year 2016 - 2020, if you claim the Earned Income Tax Credit (EITC) or Additional Child Tax Credit (ACTC) on your tax return, the IRS must hold your refund until at least February 15. In the past, the IRS has issued most refunds in less than 21 days (10 days or less, if paid by Direct Deposit). If you elect to receive a check, it could take 4 weeks or longer. Amended Returns will take up to 16 weeks or longer due to COVID-19 delays. However, UBUTPE will accommodate your requests. After the first initial deposit from the IRS in 2019, the normal refund time will be the same as usual.

INQUIRE ABOUT OUR TPG BANK /FAST CASH ADVANCE PROGRAM, IF YOU ARE IN NEED OF SPECIAL FUNDS PRIOR TO RECEIVING YOUR TAX REFUND. THIS PROGRAM IS AVAILABLE AFTER YOUR TAX RETURN HAS BEEN RECEIVED BY THE IRS. ASK US ABOUT THE DETAILS.

Please keep in mind it is always possible, but not likely, that your tax return may require additional review and be delayed if you have dealt with any <u>Identity Theft issues, Child Support</u> or Student Loan issues, <u>EIC</u> <u>Credit fraud</u> or other unknown or undisclosed delays. It is our goal to "Maximize Your Tax Dollars" and "Do It Right the First Time," <u>so please disclose any potential challenges you might be facing so we can help</u>.

If you received an Identity Letter Request from the IRS, no need to panic. Simply follow instructions that also appear on our website at www.ubutaxpros.com, call them and verify the information requested <u>only.</u> Do not volunteer information. This is not an audit. It is meant to combat fraud.

If you receive a mail audit letter, do not panic. It is no one's fault. Under the 2015 Path Act, the IRS randomly selects returns for verification. <u>It is important that you keep all receipts during the year whether</u> <u>you think you need them or</u> not. If you chose Tax Protection Plus, simply contact the company and they will assist you. If you did not choose Tax Protection Plus, call UBU Tax Pros so that we may direct you further, Be sure to send a copy for your tax file. Though it is your choice, UBUTPE suggests that you accept Tax Protection Plus to safeguard you in the event of an audit, <u>which is usually very unlikely</u>.
